**Building Blocks of Wills, Estates & Probate 2020** offers a program in which seasoned practitioners will take you through the legal, practical and ethical issues often encountered in an estate and trust practice, with a focus on Basic Estate Planning, Elder Law Planning and Medicaid, starting an Estate and Trusts Office, Probate Procedures and Alternatives, and Administration and Settlement of Estates. The course offers 6.75 hours of MCLE, including 3.00 hours of ethics. The course applies to the College of the State Bar of Texas and to the Texas Board of Legal Specialization in Estate Planning and Probate Law.

The price for the course for members of the LABA is \$160.00 and for persons who are not members of the Association \$250.00. Legal Assistants are welcome. If the employing lawyer is a member of the LABA, the Legal Assistant pays the member price; otherwise, the non-member price.
